Applicant must have access to annotated codes and case reporters for all relevant authorities.

III. Application for Special Consideration:

In lieu of, or in addition to, the above provisions, an applicant may make application the LRIS Committee, in person or in writing, for consideration of the attorneys legal education, experience and special qualifications for participation on the Insurance Law Panel.
