- ☐ **Copyrights:** Within the past three (3) years, applicant must have filed two (2) Federal copyright applications or handled two (2) matters concerning the transfer, licensing, renewal, or infringement of copyrights.
- ☐ **Patents:** Applicant must be licensed to practice before the U.S. Patent and Trademark Office.
- ☐ **Unfair Competition:** Applicant must have handled at least three (3) contested unfair competition or trade secret cases.
- ☐ **Computer Related Law:** Applicant must have prepared contracts and represented vendors, purchasers, or developers of computer software in at least five different matters.
- ☐ **Intellectual Property Litigation:** Applicant must have handled through trial at least three (3) matters involving intellectual property litigation.

III. Minimum Library Requirements:

Applicant must have access to annotated codes and case reporters for all relevant authorities.

IV. Application for Special Consideration:

In lieu of, or in addition to, the above provisions, an applicant may make application the LRIS Committee, in person or in writing, for consideration of the attorneys legal education, experience and special qualifications for participation on the Intellectual Property Law Panel.
